Yet injustice is all around us.


There's never been a more urgent need for Headwaters

1988 Headwaters and **TakeAction Minnesota** go way back. To 1988 in fact, when we awarded the first of many grants to TakeAction's two founding organizations: Minnesota Alliance for Progressive Action and Progressive Minnesota. We supported their growth through the 1990s. So their merger in 2006 electrified us and Minnesota's progressive landscape, combining MAPA's political clout and Progressive Minnesota's organizing expertise into one political powerhouse. Today, TakeAction is harnessing the energy of those working for social and economic justice into a dynamic movement that's transforming the very nature of our democratic process.


Today Economic injustice. Minnesotans are butting up against failed policies everywhere these days. Bad mortgages. Benefit cuts. Regressive fees and taxes. And a health care "system" that's anything but. More and more people are working harder for less and less.

We've got no time to lose when so much has been lost.

Welfare is supposed to tide you over and lift you up when you're down. But the way the system works robs you of your dignity. Incomprehensible paperwork. Digging up documentation again and again. Discrimination and inconsistently-applied policies.

The Lydia Women's Empowerment Project is bringing together low-income women, primarily African American, to challenge inequalities in the state welfare system. Demanding institutional accountability. Consistency from welfare workers. Streamlining the process.

But it's about much more than the welfare system. They're reclaiming their dignity. Tapping into a culture of mutual support and learning the skills of community organizing—skills that give them the power to address other issues affecting their lives and families. It's cutting the red tape. And tying the community together in an even stronger way at the same time.



1989 Wild rice is sacred to the Anishinaabe people, and Headwaters is supporting work to protect it from genetic contamination on the White Earth Indian Reservation in northern Minnesota. The **White Earth Land Recovery Project** is reclaiming land stripped away through unethical sales, treaty-breaking or confiscation—land that's been stripped of its spirit through commercial logging and farming. Restoration of wild rice cultivation has led to a restoration of Anishinaabe culture and a groundswell of self-sufficiency, self-determination, and self-respect. It's sustainability of the land *and* the people.


Today Environmental injustice. The ground is shifting rapidly as climate and energy policy debates escalate. But they're policies that leave a lot of people behind. Or treat their neighborhoods as toxic dumping grounds.

We're not waiting for things to heat up.

Being "green" is all the rage, but it's often just a surface change. The product of clever marketers. The **Center for Earth, Energy, and Democracy** (CEED) is looking at climate change and energy issues through the lens of social justice. And things aren't looking too rosy. Why aren't toxic sites cleaned up in low-income areas? Why do low-income neighborhoods end up with more of the power plants and pollution?

CEED is giving disenfranchised communities the tools they need to take a stand against big-business pressures, creating solutions that enhance neighborhoods rather than degrade them. Like the Sustainable Energy Utility, which promotes community solutions to how energy is created and used. Things like local solar installations or accessible capital so people can reduce their energy consumption.

CEED is working to electrify today's environmental debates by challenging the power behind the power policies.



1994 The movement to end domestic violence wasn't exactly mainstream back in the early 1980s when **Casa de Esperanza** opened its doors, and certainly not for Latinas. Neither was Headwaters' support for their program for abused lesbian Latinas. Casa de Esperanza understood that abused Latinas need more than a place with Spanish-speaking staff. They need a place where Latino culture is understood, too. A place that understands the importance of *la familia* and the role of women in it, and that Latinas might have different solutions. Casa de Esperanza is still breaking new ground today, both here in the Twin Cities and through national and international partnerships.

Today Racial injustice. With the election of the first African-American president, some have claimed that we've untangled the problem of race once and for all. Wishful thinking, perhaps, because things are looking more frayed than ever, with rising dropout rates, packed prison populations, and escalating violence against immigrants. Fear and racism are as rampant as ever—and they're more overt.

We're creating tomorrow's answers today.

Immigrant students face many barriers to quality education, and in some unexpected places. English Language Learner (ELL) classes, designed to be a bridge to success, can become a kind of educational quicksand—immigrant students are sometime placed there whether they need to be there or not. Sometimes it's just lower expectations from schools. Immigrant parents, through language or cultural issues, often feel unable to challenge school authorities and demand change.

That's where immigrant students can lead the way. **CrossingBarriers** grew out of a grassroots movement in Minneapolis to challenge the quality of ELL instruction for immigrants, and has since developed similar projects around the Twin Cities. Like at Eden Prairie schools, where immigrant students are working to eliminate racial tensions and improve the ELL system. They are learning how to document issues, speak before school boards, make films, energize their communities—in short, acquiring the leadership skills they need to create and implement their own proactive solutions. They're dismantling the obstacles that stand in their way—and making the path ahead easier for all of us.



1986 Headwaters was there when **Minnesota AIDS Project** opened their doors in 1986. Back when HIV/AIDS was new and stigma was at its worst, born out of prejudices about gay men and ignorance about the disease. It was a courageous move, but a vital one. We needed local leaders who would meet the stigma head on with facts and figures. People who would put together the resources and coalitions needed to combat HIV/AIDS on every level. Twenty-three years later, Minnesota AIDS Project continues to lead Minnesota's response to the HIV/AIDS epidemic with the same courage and creativity, supporting individuals in hope and shaping today's policies.

We don't wait around when there's work to do.

Today Social injustice. If we look back in history, we see things that now seem so utterly obvious to us today. Slavery was wrong. Chaining people with mental illness to the wall was wrong. Burning "witches" was wrong. How could people be so blind to the injustice? Yet one hundred years from now, what will they say about us?

The GLBTQ (gay/lesbian/bisexual/transgender/questioning) community is often treated as a monolith. As if the issues were all the same no matter which part of the acronym you identify with. But the transgender movement is emerging on the scene and starting to challenge ideas of inclusiveness—even within the GLBTQ community itself. And the general public is only starting to take note of trans issues. Even basic things like restroom options need to be reassessed.

There's a way to go yet, but transgender youth are out in front. **Trans Youth Support Network** is training trans youth leaders so that they can define for themselves the issues most critical to them and create their own solutions. Their success can have long-term consequences for all of us, too. It's the freedom to define our own identities—including gender—and the freedom to express them.

We are the ones we've been waiting for.

Justice doesn't happen by chance. It takes the right people working together—developing skills, gaining power, building momentum—over time to turn an idea into change.

What follows is a list of groups, organizations, and individuals that embody the very spirit of Headwaters—people with knowledge plus ideas, resources plus wherewithal, and courage plus tenacity to propel us forward.

Headwaters fosters an environment of mutual learning and respect by combining grant making, capacity building, and donor organizing to support and strengthen organizations and to build an even stronger movement for justice.

These are just some of the things we were able to accomplish **together over the past two years.**

Held our 10th Annual Allies for Justice—honoring the work of donor activists Barbra Wiener and Catharine Reid, and grantees Somali Action Alliance and MN ACORN.

Trained 650 individuals from 110 organizations through our capacity-building program.

Helped 130 groups raise over \$230,000 through our 2007 Walk for Justice.

Awarded \$702,500 to 51 organizations through our activist-led grantmaking process.

Hosted events to help nonprofits become more connected and effective, including: 14 trainings, 5 convenings, 12 fundraising brown bags, and 8 movement-building sessions.

Partnered with local organizations to bring forward-thinking programs and speakers to our grantees and donor activists—partners included the University of Minnesota GLBT Programs Office, East Hillside Patch in Duluth, Organizing Apprenticeship Project, Intermedia Arts, Institute for Agriculture, Trade and Policy, Healthy Legacy, and Common Roots.

Directed \$337,000 to 49 organizations through Donor Advised funds, thanks to our donor activists.

Reached our goal of raising \$1.75 million for the Fund of the Sacred Circle Endowment, enabling us to get more resources to Native-led groups.

Invested in strategic partnerships—with PFund Foundation, Women's Foundation for Minnesota, Minnesota Environmental Fund, the Minneapolis Foundation, Grotto Foundation, and Native Americans in Philanthropy—on projects helping to advance social justice in traditional philanthropy.

Reached a milestone. We celebrated our 25th birthday. And got back to work.

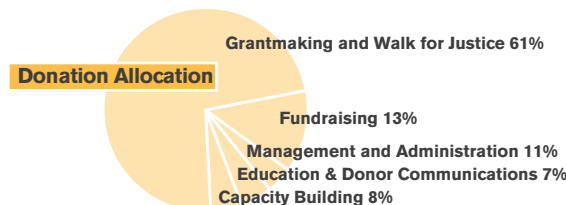

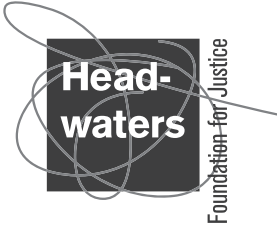
